Discussion: Board to consider ways to promote diversity and inclusion of all genders in figure skating.

Discussion: Flat fee credit for a Spring/Summer session for multi-day incentives for the next term. Example: If you do two or more sessions in the Winter, you will receive a 50\$ credit to be used towards skating in the Spring or Summer. Discussion, find an average and round it up (example, 4 CAN Skates a week, only give an incentive for 2 or more).

Motion to create a Can Skate multi-day incentive policy that reads "if you participate in two or more CanSkate sessions a week in the Fall and/or Winter terms, you will receive a 50\$ credit (per term) to be used towards skating in the Spring or Summer sessions." This policy will be retroactive for the 2022 - 2023 Skate Canada sessions (i.e. the Fall 2022 session participants who qualify will get a credit).
